1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Karimpur is geographically located as the borderline between Nadia and Murshidabad district of West Bengal and it is also very near to our neighboring country Bangladesh. So the place has its own socio-political and cultural importance from the very beginning. On 4th August, 1968 as a 'Home of Higher Education' Karimpur Pannadevi College was established to cater higher education to the people of Karimpur and its vast locality, particularly for the students belonging to the poor and middle class families who cannot afford to go far off places for meeting the demand of higher education. The establishment of the College was possible with the indomitable zeal of Dr.Nalinaksha Sanyal, an illustrious son of the soil and the donation made by Sri Durga Prasad Agarwala, and the College was named after his wife Pannadevi Agarwala.

The College has now a three-storied building measuring about 40,000 sq.ft., having a campus of about 7 acres. Presently the College offers education to around 4,000 students of Arts, Science and Commerce streams. Students come from different corners of the locality. The college has its well furnished spacious Guest House and Womens' Hostel ready for the students.

The College aims at upliftment of the people of the locality, particularly the poor and middle classes, through spreading higher education leads to employment. Since its inception, the college is committed to transforming the darkened demographic situation into an awakened one by imparting higher education to the aspiring youth.

Since inception, the college was affiliated to the University of Calcutta and from 1999-2000 onwards the College is affiliated to the University of Kalyani at the undergraduate level. The College has got its recognition from UGC under section 2f & 12B.

Now as the Kalyani University has introduced the Choice Based Credit System (CBCS) under its colleges, we also go for that and successfully executing the course of study. The new scope and interdisciplinary variety has opened the new avenue for the stake holders. Since most of the students are first generation learners and many of them belong to SC, ST, OBC, Minority categories and families of marginal farmers and land labourers with very limited financial capability, the programmes are primarily aimed at attaining long-term perspective of the education to uplift the society with higher education and their advancement.

1.2 Strength, Weakness, Opportunity and Challenges(SWOC)

Institutional Strength

- 1. Karimpur Pannadevi College has young and enthusiastic qualified faculty members almost 50% of its permanent full-time teachers have Doctoral degrees and two has executed Post-doctoral research. In addition, a number of teachers have registered under Ph.D. programme.
- 2. Teachers are encouraged to participate in Faculty Development Programmes and carry out Research. Many teachers are engaged in research; they publish their work and even apply for patent.
- 3. The College organizes International, National Seminars, Webinars and Popular Lecture Series at regular basis for students as well for as for teachers where eminent academicians deliver lecture on their specialized area.
- 4. All the departments follow Academic calendar, Teaching Plan for timely completion and efficient delivery of course objectives. Monitoring of students' performance is done by holding unit/ mid-term tests and examinations.
- 5. The teaching-learning at Karimpur Pannadevi College is learner-centric and interactive including application of state-of-the-art infrastructure and resources like ICT, Smart-class rooms. During lockdown online classes were taken by using different digital platforms, like Google classroom, Google meet, creating Whatsapp groups etc.
- 6. The College has established Career Advancement and Placement Cell, Anti-ragging Cell, Women Cell, Grievance Redressal Cell, Staff Welfare Committee, Cultural Committee, Girls' Common room, Boys' Common room and Students' Union to provide various types of support to the students.
- 7. The College has a considerably large and open play ground for performing and practicing different Sports related activities and multi-gym which are also helpful for students who opt for Physical

Education as an elective subject.

- 8. The institution promotes institution-neighborhood community network by engaging its NCC, NSS, Eco-Club and other students in diverse activities among the socially and economically challenged section of the society. These activities and programmes along with seminars on value-education instill among the students a sense of moral, social and civil responsibility leading to their holistic development as responsible citizens.
- 9. Office and Library of the college are almost computerized and automated. At present there are 19 desktops, broadband internet at different locations like in the office, library, Computer Laboratory etc.
- 10. The college also as a whole stresses upon energy saving and hence it pursued the appropriate authority (WEBREDA) to construct and install Solar-panels on its rooftop and has succeeded in doing so.
- 11. The College promotes multi-cultural and multilingual environment to uphold the spirit of national integration. At the same time, it boasts of local culture and heritage particularly that of the local minority communities and offers scope to the students to celebrate the same.
- 12. The College has a strong, stable and responsible Governing Body .The Governing Body runs the administration and other activities based on participatory management system by delegating assignments, duty and responsibility to different subcommittees and advisory bodies for smooth running andoverall development of the institution. It has also stressed upon the decentralization pattern of administration through various sub-committees which helps in the smooth functioning of the day to day college as final decisions are taken up through part to the whole procedure.

Institutional Weakness

- There are very few courses (Honours or General/ Programme Course) in Science subjects and no career oriented/self-finance courses can be offered by the College. In addition, there is no diversity in courses to cope with the demands of the new generation as the college has to follow the directions of its affiliating university and depend upon the Department of Higher education for introducing new courses.
- 2. No new courses and programmes can be offered even if the college wishes because it has to depend upon the Department of Higher education for introducing new courses and limited flexibility in curriculum design due to restricted participation of the teachers in the Board of Studies of the affiliating university. Full-time faculty of teaching staff in all the running courses are filled up but due to nonadmission of students in Commerce and Economics for decades the Governing Body has resolved for its closure and it has been eventually applied before the Higher Education Directorate so that the posts in those subjects can be converted to other subjects where there is dearth or no teacher. As for the fulltime non-teaching staff ninety percent posts are vacant because the College has no freedom to recruit staff against the vacant posts as and when required because this process is carried out by the State Government and its approved bodies.
- 3. The College had to recruit adequate numbers of casual staff for the benefit of students by paying their salaries from its own fund compromising other developmental projects.
- 4. Poor transportation connecting the nearby towns/cities makes the journey hazardous for the students and staffs as well.
- 5. Poor telephonic and internet connectivity in the area where the college is located hampers and delays many regular and developmental activities. However, the college is trying its best to overcome it.
- 6. Absence of provisions for external auditing of academic and administrative activity undermines sustainable development and optimum use of resources and infrastructure.
- 7. College is unable to provide transport facilities for its staff and students on its own.

Institutional Opportunity

OPPORTUNITY:

- 1. The College has seven acre of lands in its possession making its future augmentation plan feasible at lease.
- 2. The College is located about 1/2km away from a small town adjacent to woods and quite far from the crowded land which makes it an ideal place of academia.
- 3. The people of the locality adore education; extend their help and cooperation to the College and its development.
- 4. The students are well mannered, considerate, respect teachers and are prone to welcome new methodology in teaching and learning.
- 5. The teachers obey and honour the administration, undertake duties beyond their teaching and research. This is an advantage for the smooth running of the College and to undertake various developmental projects without external help and associated expenses.

Institutional Challenge

CHALLENGE:

- 1. Attendance of students in the classes of some courses needs to be increased and their dropout rate needs to be decreased.
- 2. To stop interest among the students and a very few teachers in private tuition without fruitful result in spite of repeated warning and arrangement for Remedial/tutorial and special classes offered by the College.
- 3. Need to offer career -oriented self-finance courses and B.Ed. course as demanded by the local youth and to arrange proper infrastructure for job placement.
- 4. 50% of the substantial amount of fund generated by the College from the students' tuition fees is taken by the Government, hampering its own developmental projects.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Curricular Aspects

The syllabi of the subjects for General and Honours courses are provided by the Kalyani University. The curricula are mainly designed by the Board of Studies of the respective departments of the University. Though, the College has little role in designing the curricula it asks the departments to deliver lessons systematically using best available resources in accordance with the convenience of the learners. Accordingly all the departments prepare and follow Detail Departmental Teaching Plans at the beginning of every academic session. They apply Smart Class Room and ICT enabled teaching learning methodologies. Field work and practical classes are arranged as required by the syllabi. Monitoring of the students performances are done by

taking several Internal Assessment tests and 'Test Examinations'. Adequate measures are taken for the poor achievers of the course objectives after every unit test and after the test examination. The list of elective options is prepared by the College considering employability and prospect of pursuing higher education in future. Now after having the CBCS System offered by the Kalyani Univesity the scope and interdisciplinary option has been increased. To groom the students as sensible, responsible and capable citizens of India, the institution arranges for value-based education in collaboration with Ramakrish Mission, participation of the students in National Service Schemes and Eco-club units.

Structured feedback is collected from student teachers and this feedback has been analysed and the action taken report has been available online. Different departments uploaded their teaching plan and study material on the college website.

The College authority tries to upgrade the academic activities required and eradicate the deficiencies in any programme in time and adequately.

Teaching-learning and Evaluation

Teaching-learning and Evaluation

There is an Admission Committee for helping the authority in enrolling the students in different courses it offers. The students are admitted in Honours courses according to their merits as per their score in the H.S (10+2) examination. A single window admission procedure with the help of College website is followed which is completely E-Admission Process(Including E-Counseling). Reservation of seats for SC, ST, OBC, differently-abled students and Sports quota in all the courses is strictly adhered to as per order of the Government. As per Rules of the Kalyani University the Internal assessment marks(conducted by the respective college) and the attendance credit are uploaded to the Student portal of the college website and concern students can get their marks by putting their password very easily. Poor achievers of the course objective are given the chance of participating in Remedial Coaching. Advanced learners are encouraged to participate in extra-academic activities like class teaching, seminar, debate, quiz, etc. Interactive teaching and teaching-learning applying ICT. Necessary resources and facilities are provided by the authority. IQAC provides with appropriate monitoring methodology and appropriate actions are initiated for improving teaching-

learning activities and programmes.

Research, Innovations and Extension

Research, Innovations

Karimpur Pannadevi College encourages research by its teachers. It has made provision for using computer and internet facilities for all researchers and research laboratory and related facilities for research in Science. It has one Research and Publication sub-committee to advise and approve topics of research projects, implementation and monitoring of performances of the projects. Similarly computer, scanner, printers and net are also shared by all teacher /researchers in the Arts departments. At present there are two ongoing research projects undertaken by the faculty of Science (Mathematics). 2 research projects have been in the last four years that have resulted in an application for a national patent, The college has published (in collaboration with a reputed Publishing house of Kolkata) an edited book title, "Women society and Politics: A Study of South Asia." Department of Political Science publishes by annual e-mega regularly. The Research and Publication sub-committee has already decided to bring out an ISSN multidisciplinary journal.

Infrastructure and Learning Resources

Infrastructure and Learning Resources

At present Karimpur Pannadevi College has now a composite 3 stored building which has about thirty five classrooms, five laboratories, one Computer Laboratory, one Central Library, four office rooms(Including Principal Chamber and IQAC Room), one Seminar Hall, two hostels, one well equipped modern Guest House, one Girls' Common room, one Boys' Common room, one office for the Students' Union and one for the Alumni Association. There is one Auditorium cum Multi-gym adjacent to the main campus flanked by a Sports Complex and medium size ground that are used for different types of sports and for organising cultural activities..

There are one Smart-class rooms equipped with laptops, LCD/LED Projectors and visualizers. There are one water purifiers (Grand Stand Alone Project *Swajaldhara*). All the bathrooms are hygienic, fitted with standard sanitary wares and connected to overhead tanks for proper and adequate supply of water. The College has already installed a Napkin Vending Machine for Girls Students at their common room. The Library of the institution has about 18000 (UGC 6928, college 11023, Gift 762) thousand books, E- journals, eight magazines and bulletins, four newspapers, reading space. for about twenty-five readers, computers, internet, printer and catalogues. INFLIBNET facility is available from the Library. Library resources and lending facilities are going to be digitized that is maintained by standard library software (Koha). For development of building infrastructure, the institution mainly depends on the financial assistances from UGC and the Government of West Bengal. In addition, small scale construction and repairing jobs are done using the College's own fund and under the planning and supervision of Development and Purchase Sub-committee.

The College ensures that the teaching-learning process is maintained at an optimal level by providing adequate infrastructural arrangements. The college has a definite system for planning and allocation of physical infrastructure and its proper utilization is ensured by the Departments and teachers.

Karimpur Pannadevi College gives due importance on various support services since one of the objectives of the College is to groom youths of the locality belonging to SC, ST, OBC and Minority communities and most whom are first generation learners. It publishes rules and regulations, facilities and resources available, examination schedule and Academic Calendar. The institution has one NSS Unit and one E-Club Unit that help the students groom their personality through various programmes and activities. The institution gives special importance in Sports and Culture. It arranges intra College tournaments and cultural activities, sends the students in different levels of Meet and Championships and provides required infrastructure, resources and supports. The College participated in the district level Youth Parliament Competition organised by the Ministry of Parliamentary Affairs, and got the medal in Individual category of Best Opposition Leader, Best script, district level runner up etc. The institution helps meritorious students with poor financial background by giving them freeships/half-freeships. In addition, it provides official formalities and helps deserving eligible students get fellowship/scholarship from the Government. The institution was awarded as the 'Kanyashree Award', in 2016 and 2020. There is Women Cell for girl students, Anti-ragging Cell, Grievance Redressal Cell and Students' Union for all students. The College has Registered Alumni Association where ex-students meet and exchange their ideas about several programmes and activities which can benefit the students and contribute to the overall improvement of the institution.

Governance, Leadership and Management

Governance, Leadership and Management

Karimpur Pannadevi College is a co-educational institute empowered and guided by the College and University Act, 2017 of the Government of West Bengal in consonance with the Statute of the Kalyani University. The College is run by the Governing Body as the highest administrative and policy making authority in which the Principal/Teacher-in-charge acts as the Ex-officeo secretary. The GB forms various Subcommittees and Advisory Bodies to delegate different jobs and responsibilities among the teachers and staff according to the Statute and Ordinance of the Kalyani University and Government of West Bengal. Academic plans and programmes, test and examinations, review of academic activities are done by the Academic Subcommittee. Augmentation, repairing and maintenance of infrastructure and facilities, purchasing and procuring are supervised by the Development and Purchase Sub-committee. The Finance sub-committee makes yearly budget, sanctions and monitors funds and do all the needful for audit by the Government's panel auditor. The College undertakes its financial audits every year and receives the reports without any negative or derogatory comments. The IQAC has given the responsibility of planning various programmes and activities at the beginning of an academic session, to act cohesively with different subcommittees and departments for implementation throughout the year and analysis of the outcome at the end of the academic session. It encourages the teachers for participating in different faculty development programme, writing research projects, papers and books. The IQAC makes yearly plans and programmes for overall improvement of academic activities and programmes and for development of infrastructure and facilities which are given due consideration for implementation by the Governing Body.

E-governance is implemented almost in every area- Administration, Finance and Accounts, Student Admission and support, and Examination.

Effective welfare measures have been taken from time to time for the Non-teaching and Teaching staff. Advance for festivals and financial assistance for any medical treatment is allowed for them. No teacher has claimed financial support to participate in conferences and workshops.

Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:

The college is affiliated under the University of Kalyani. So the college has limited scope or none to frame its own curriculum and offer subject combinations to the students. The combinations

	offered to students mainly depend on the subjects which are taught in the college, subject to the approval from the University and teaching posts sanctioned by the Department of Higher Education. Still, the college has both Arts and Science faculties and the latter is twofold: Pure Science and Bio- science. However, the college within its limitations has achieved some results in the matter of Interdisciplinary Approach. For example, certain relevant portions from the Geography Syllabus are taught by the teachers from the Department of Zoology. Moreover the Departments of Mathematics, Chemistry, Botany and Zoology has jointly organised certificate courses on Population Dynamics. Furthermore, the Eco Club of the college brought the Departments from Pure Science and Social Science and organised certificate courses on Environmental Sustainability which is a remarkable interdisciplinary approach.
2. Academic bank of credits (ABC):	In the matter of designing a curriculum or in the matter of introducing Academic Credit Bank, the college has practically no freedom as it has to follow the dictates of the affiliating university.
3. Skill development:	As for the introduction of vocational courses the college has scarce infrastructure and the scope is limited too. But the college endeavours to fill up the lacuna by arranging Life Skill based job oriented training programmes on Career Building and the like. Since the students come from hinterland regions with poor economic background, the college has introduced GRACE (Guidance to Reach Academic and Competitive Examinations/Entrances) where interested teachers offer free coaching to students of 4th & 6th Semester outside the college hours in excess to their syllabus oriented allotted classes within the college premises.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	The vernacular language of the students is Bengali and the medium of instruction in the college is mainly Bengali. The college language courses particularly in the following subjects- namely English, Bengali and Sanskrit. Through Sanskrit the students are introduced to the Classical Indian Culture and Tradition. Through Bengali (here the medium of instruction is Bengali only) the students are made aware of their own culture, traditions and effects of foreign traditions on their mother tongue.

	Same is also applicable for English where the medium of instruction is solely English and as per the curriculum the students are made aware of not only the culture, tradition of the British isles but also glimpses of the European world and the profound effect of colonialism upon the native literatures through Indian writings in English or translated works of native literature and the problems of hegemony. As for other subjects, though the primary medium of instruction is Bengali, keeping in view the scopes in home and abroad, to help students to pursue Higher Education in the national or international level, the teachers take classes in English and follow and instruct references from English books. The college has taken needful steps for the inculcation of Indian Culture and Values among its stakeholders and for that in collaboration with the Ramakrishna Mission it has organised Add-on courses on Value Education. The college also regularly arranges Seminars on Value Based Education and workshops on Yoga and Meditation.
5. Focus on Outcome based education (OBE):	Karimpur Pannadevi College has adopted student- centric teaching and learning methodology. The teaching-learning process of Karimpur Pannadevi College is mostly 'with' the students rather than 'for' the students, where the outcomes are generated from a team-work. For example, regular executing internal assessment and conducting student seminar, collection of student feedback, providing best student award for motivating the students, student excursion, departmental project work, orientation program, conference/seminars/webinars. Using Google Classroom as a LMS tool so that the students and teachers can always stay connected and participate in academic discussions.
6. Distance education/online education:	The traditional chalk and talk system is widely used by the teachers while delivering lectures. But to meet the demands of the age teachers have also gone for digital mode of teaching-learning through various online platforms. Moreover, not all but a few, some teachers with their personal invigoration upload their lectures and study materials online for the benefit of their students and the same is simultaneously uploaded in college website in the respective departmental sections.

1.1.1 The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

The College is provided with a suggested curriculum from the affiliating University for respective subjects and the delivery of this curriculum is done by chalk and talk method, still to make classes interesting to students and at the same time to complete the curriculum within the stipulated time the teacher's have to deal with the matter with time management skill and that too with due efficiency. Since CBCS has been introduced the teacher has to modify the guide map in accordance to the credit given against a particular subject. For efficient delivery of the curriculum the teacher's adopt the following methods:

- 1. The departmental teacher in a meeting among themselves chalk out who is going to teach which portion of the curriculum.
- 2. Each teacher then chalks out a lesson plan for the weak he/she chalks out which areas he will discuss sequentially and makes a details scheme of introduction to scheme of introduction to conclusion within the stipulated number of classes allotted to teach the topic.
- 3.On their preparatory day, the teachers devote their time in the library and make lists of reference books which will be helpful for the students and also makes a list of relevant portion.
- 4. At the end of each class, the teacher holds an interactive session with the students to answer their queries and clear their doubts.
- 5. After completion of a particular topic, the teachers call for a kind of paper presentation in the classroom from among the students on various aspects of the topic taught.
- 6. For generating a clean consciousness about the subject the teacher's some time hold classes in the smart classroom of the college through the ICT method.
- 7. Through audio-visual aid, a teacher is able to present before the students those things which they are only aware of as printed data in the pages of the book.

It is the duty of the institution to cater to their needs, especially in the field of learning. But the college has to perform various assignments including examinations, admission, seminar and workshops, cultural programmes, students' council Fresher's Welcome Programme, observations of various red letter days and their vacations and holidays also. All the days of the year cannot be devoted to the purpose of teaching and learning. But to give them the best and to utilize the best number of teaching-learning days an academic calendar is a must. The college prepares an academic calendar and gives it to the college website which reflects the various assignments and tentative schedules to help the teachers and students to complete their curriculum within the stipulated period of time. The academic calendar presents a consolidated idea to the students about the tentative schedule of their fresher's welcome ceremony, cultural and athletic events, dates of internal assessments, university examinations, vacation & holidays. Hence it is helpful for the students to make preparations for examination utilities the best of the teaching-learning days.

2.3 Teaching- Learning Process

2.3.1 Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences using ICT tools

Response:

Different departments apply different modes of student-centric and interactive learning methods suitable for their subject of teaching.

- 1. Uses of charts, graphs, models, maps, etc., arranging quizzes and group discussions on the topic already taught in the class, brief lectures by the students at the beginning of a class, enacting a drama on the topic in linguistic subjects, fieldwork, games, sports and practical classes in science subjects, etc. are practised as a part of student-centric and interactive learning methods. The students get the opportunity of collaborative learning by participating in quizzes, group discussions, fieldwork, games and sports, and practical classes in groups. The institution has a Media Centre for preparing charts, graphs etc., teaching aids, one seminars hall, four smart classrooms, OHP, and the necessary support structure and system for the purpose.
- 2. Besides these kinds of traditional methods, the college undertakes many student-centric methods for enhancing learning experiences. One such method is **Mentoring System for Students** to minimize drop-outs through personal counselling. In modern times students undergo various problems of stress. Considering the student-teacher ratio in classrooms, it is impossible at times to give personal attention to students in class. One solution, therefore, is a Mentor who can form a bond with students in the true sense. Mentoring is required for students to achieve emotional stability and to promote clarity in thinking and decision-making for the overall programme. Each teacher is assigned a few students from the concerned departments. As there is a shortage of teaching staff there is no uniform rule on how many students will be allotted to a teacher. They meet at least once a week to discuss, clarify and share various problems which may be personal, domestic, academic etc. The teacher involves local guardians and parents as well, whenever

necessary. The students are asked to share their e-mail IDs and mobile numbers with the teachers and their peers so that a social network is established.

It is needless to say that a mentor gets job satisfaction. Evidence of the success of the practice includes better results in the examinations, more regular attendance, increased participation in co-curricular activities, better discipline on campus and respectful relationships between teachers and students. Prospects of turning out as a well-adjusted citizen and a responsible human being also increase through this process.

2.5 Evaluation Process and Reforms

2.5.1 Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

As per the new CBCS, the college has to arrange the two Internal Assessments tests, along with the Assignments to full fill the examination procedure of every semester and at the same time Class-Tests, Mid-Term Tests, Selection Tests prior to the First, Second and Third Part Examinations scheduled by the University of Kalyani for the student who is under the previous system of Annual examination system(1+1+1) results are duly intimated to the examinees within 7 to 10 days of the examination. The students are provided with the corrected answer scripts by the relevant faculty members. The doubt and enquiries of the students regarding the pattern of optimal answers are clarified by the examiners. The students are provided with the corrected answer scripts for the Class-Tests so that they can be aware of their mistakes. If the students express their difficulties in understanding the questions which were set in the Test, the questions and the topic on which such questions were set are discussed during the lecture hour by the faculty member. The students are often suggested to write the answers again as home assignments incorporating the modification and changes made by the examiners in the test scripts. If there is any tabulation-related error in the assessment, corrections are duly made by the examiner and the corrected marks are officially posted against the name of the concerned student. However since the responsibility for publication of final examination results lies solely with the University of Kalyani, delay in the publication of the 1st and 2nd-year results is something which the college has no way to rectify.

Mechanism to deal with examination-related grievances is transparent, time-bound and efficient:

- 1. After evaluating the students writing and oral skills, the marks are uploaded to the **'Student protal'** where an individual student can see his/her marks personally. If a student feels dissatisfied with his/her examined answer scripts(s) where the teacher/examiner personally points out the faults made and gives counsel to the concerned student on how to overcome his/her weakness and mend the loopholes of his/her understandings. But after few midifications of the University examination in time of Lock down period the "Student portal" seems irrelevant we have left it out from our website.
- 2. The students are provided with the **corrected answer scripts** by the relevant faculty members. The doubt and enquiries of the students regarding the pattern of **optimal answers are clarified by the examiners**. If there is any tabulation-related error in the assessment, corrections are duly made by the examiner and the corrected marks are officially posted against the name of the concerned student.
- 3. The Parent-Teacher Meeting is occasionally held when necessary. The last meeting was held before the lockdown period but was discontinued after that. The ffedback report of the last meeting is

documented along with.

- 4. In case the student suffers from psychological instability or examination-phobia, the faculty members try to deal with the suffering students and their parents sympathetically.
- 5. Moreover a timebound grivance redressal chart along with concerned authority is reflected on our website to inform the stakeholders and also the online form to register their grivances.

They are encouraged to develop communication skills and gather current information which will help them to face the world of job in the outer world. The practical based subjects helps to develop analytical and logical sense among students and they get habituated to handle time management . Apart from this the college often organizes certificate/ add on courses on value education which inculcates ethical values , among students and imbibes in them the moral sense to become ideal citizens of the future . A similar courses on Spoken English, Computing Skill and Yoga help to develop their Head-heart and Hand simultaneously. Introduction of NCC as an elective subject from AY 2022-23 will also certainly inculcate among students the value of teamwork and discipline.

3.4 Extension Activities

3.4.1 Extension activities are carried out in the neighborhood community, sensitizing students to social issues, for their holistic development, and impact thereof during the last five years.

Response:

To fulfil the institutional commitment in respect of both academically and socially Karimpur Pannadevi College has taken the following initiatives. The activities can be classified into different categories like health survey, gender issues, social responsibility or service, social harmony, cleaning, promoting awareness etc. The college NSS, NCC and Eco-club organizes several programme on the above issues in collaboration with other Government and non-government issues. To provide a ethical and social value among our students this kind of extension activities are arranged regularly by the college. Since 2017-2018 several activities were conducted in the neighbourhood areas of the college and CNCP, the orphanage, Pattaboka and sometime we invite neighbourhood schools, Communities members, students for taking active part in the programmes. These social activities developed their personality and help to built a good character. Academic development is coupled with character and moral development which is essential for the day. We think these activities surely help to achieve a balance personality.

Social-service orientation:

- 1. **Blood Donation and Eye Camp:** Almost every year blood donation camp has been organized by the college to promote a sense of social service in unselfish way among our students.
- 2. Garments and drawing materials Distribution: There are three orphanages in the Karimpur area where 75 helpless children and a few widows are leading very hard life with so many difficulties. Considering this, the college has taken the opportunity in collaboration with the Alumni Association of the college to offer winter garments to those hapless children by which they can get relief from the cold.

Awareness programme and Gender issues:

- 1. Sensitizing and Awareness Programme of Local Women and girls Students: Karimpur is far from the city area of Nadia. Rural women and girl students are not aware of their legal rights, future prospects, their economic prosperity, women's health and legal aid. To full fill all these objectives and to make aware them to protect child marriage a Seminar was organised by the Women Cell of the college.
- 2. Science Awareness and Cancer Awareness Programme: Under the series of Popular Lectures the IQAC of the college has arranged two most valuable and necessary lectures on Popular Science and Food and Cancer. The people of the locality were invited to make them aware of these two burning topics. 95 students from the neighbouring schools attended this programme.
- 3. Women's health and personal Counseling programme: Women's cell of the college organised a workshop on personal counselling and women's health as a part of its regular activities. Doctors and

health officials of Rural hospitals were present in the workshop to give answers to the students.

Health survey and Cleaning: To sensitize the local rural people about health related issues and to provide some general guideline NCC and NSS regularly arranged rally and survey.

Teaching -Learning Equipment in the classroom:

The institution has twenty (20) fully functional Classrooms along with white board. The mode of teaching is both conventional Chalk & Talk method along with Digital mode.

Digital Classrooms and ICT-enabled classrooms

- Our auditorium which can accommodate more than 650 students has a set-up of the interactive digital board with digital surround speakers and cordless microphones and lapels.
- One of the classrooms has been upgraded to a smart classroom with a high-end interactive digital board, and a desktop computer with a Wi-Fi facility.
- One gallery room is also equipped with a portable projector and automatic motorized screen.

Library facilities:

The Central Library is partially automated. It has a rich and varied collection of books, some rare and no longer in print, and academic E-journals, both national and international. INFLIBNET/ NLIST facility is available for teachers.

Computer and internet facility is available for the campus is also Wi-Fi enabled for everyone

Laboratory Facilities:

The science departments along with geography have well-equipped laboratories along with computer and internet facilities.

Teaching - learning support systems:

Laboratory infrastructure for the Department of Chemistry:

The chemistry laboratory is situated on the ground floor of the building. The laboratory has five sections: Qualitative Laboratory, Quantitative Laboratory, Instrument Room, Preparation room, and Storeroom. Qualitative Laboratory has different reagents and few instruments for Qualitative analysis. Quantitative Laboratory on the other hand is equipped with analytical-based equipment and reagents. The instrument room is well equipped with digital instruments required for students like a sophisticated weighing machine, digital calorimeters, potentiometer etc. For safety inside and outside the laboratory is equipped with fire extinguishers.

Laboratory infrastructure for the Department of Physics:

The physics laboratory consists of five sections, situated on the ground floor of the college. General lab, dark room, electrical lab, electronics lab and computer lab. The general laboratory and the dark room, being the oldest, displays a rich and well-maintained collection of the experimental set-up of three years of general physics course. The well-furnished dark room for experiments on light has a plentiful experimental set-up for both General and Honours students. The electrical and electronics laboratory is very well equipped and fairly maintained. Each set-up is a collection of different apparatus like power supply, galvanometer, CRO, Electromagnet, search coil, resistances, thermo-couple etc.

Department of Geography:

Geography Laboratory Consists of two sections, situated on the ground floor of the college. One is the instrument room and another is light tracing. There are various types of instruments such as Dumpy Level, Theodolite, prismatic compass barometers, and telescopes. There is also a map of different countries. There is another room, where there are eight light tracing tables operated by an electric system.

Department of Mathematics:

The department's classes are equipped each with a white or black wall-mounted board. Some classrooms are technology-enabled with projectors and screens for audio-visual presentations. There is a computer lab in the college used by the department. The lab is well equipped.

6.3 Faculty Empowerment Strategies

6.3.1 The institution has effective welfare measures and Performance Appraisal System for teaching and non-teaching staff

Response:

Since the development of the college depends a lot upon the proper functioning of duties arranged to her Teaching and Non-Teaching staff, it is the duty of the college to double after their welfare in time of need.

- 1. The college provides food against the allotted centre fees for the staff during University Exam When staff has to arrive the college at 9.00 a.m. and has to leave not before 5.30 pm. So on humanitarian ground the college tries to provide sufficient food/beverages within her capacity at the time of break between two halves of examinations.
- 2. The college G.B provides scope for availing interest free loan for its staff esp. for their medical needs of him/herself or any family member which is to be refunded in equal installments within a stipulated time.
- 1. Since in West Bengal Durga Puja is the biggest festival, the college offers Puja advance/ex-gratia to staff against post dated cheque for the sake of the festivity of the season and that is to be realized before the commencement of next financial year. Since the casual NTS Guest teacher do not avail any monthly contribution from the Government, the college has made provisions of non-refundable bonus within her capacity for the sake of the festivity of the season.
- 1. The college responded to the various health schemes introduce by the college when whenever any employee wants to be a part of it which includes the West Bengal Government Health Scheme and "Swasthya Sathi" project.

1. For the female staff of the college the college grants them required maternity leave during child

birth and also grants them Child Care Leave (CCL) within the bound of the rules of the Govt. of West Bengal. Male teachers are also granted Parental/ Paternity Leave (PL) and that too as per norms frame by the Government of West Bengal.

6.4 Financial Management and Resource Mobilization

6.4.1 Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/ nongovernment organizations) and it conducts financial audits regularly (internal and external)

Response:

Being an institution located in hinterland, the college within its limitations tries its best to utilise available government & non-government funds for its infrastructural and academic developments.

The college has time and often pursued the local bodies to contribute for its infrastructural development and as the result of it the college road, two classrooms has been constructed by the B.D.O. office. Electrical renovations have been made with the aid from MP LAD fund of Smt. Mahua Moitra and Solar Panels has been installed on rooftop at the contribution from the Ministry of WEBREDA, Government of West Bengal. Regarding the latter the college has reached for an agreement with the WBSEDCL, Karimpur and it's a matter of good news that at recent times the amount of electric bills has got lowered by a considerable amount.

As for research activities, as funds from the UGC is unavailable at present, alternative funds has been arranged from SERB-TARE and Research Grants from "Egiye Bangla/Gobeshonay Bangla", an initiative of the Government of West Bengal and proper utilisations are submitted from time to time before the

concerned granting authorities.

Seminars and symposiums of National and International levels were held with funding from MAKAIAS, ICSSR (ER) & ICSSR (New Delhi) and proper utilisations had been submitted from time to time before the concerned granting authorities.

As remains the question of financial audit of the institution, the college being a Government Aided one and is liable to follow orders and circulars time to time as issued by the Higher Education Directorate, Government of West Bengal it has no freedom to appoint auditors of its own. Financial Audit from the Financial Year 2017 to 2020 has been completed by appointing Audit Firms as recommended by the Higher Education Directorate, Government of West Bengal and the Audit report for the same has been duly submitted to the concerned authority. Application to provide Auditor for assessing the period from the Financial Year 2020 to 2022 has been submitted to the Higher Education Directorate but response regarding recommendation of the panel of auditor(s) is yet to be received and the college will expedite the matter at the earliest when the response comes from the concerned authority. However, the college office maintains the records of regular financial transactions through bill, vouchers, cashbooks, ledgers and those are regularly monitored by the Bursar of the college.

To establish the security and safety of girl students, the college has also framed an Anti-Sexual Harassment cell sticking to the norm of U.G.C. The College has taken initiative for the betterment of girl students by actively promoting the *Kanyashree Prakalpa* and no girl student is denied of her rights in this Scheme. Response:

Karimpur Pannadevi College is situated in the hinterlands of West Bengal where the means of survival of the people are mainly farming, agriculture and business. This diversified population is primarily comprised of reserved category Hindus and Muslims and a spurious number of Christians, Jains and general category Hindus. Since this is the only undergraduate HEI within a radius of almost 40 km the students, mostly first-generation learners, get admitted to this college. Education means the overall development of an individual, so besides traditional curriculum-based teaching-learning, the college tries to impart values among them which must comply with the demands for making an ideal citizen of India. This includes an

awareness to inculcate a harmonious coexistence among themselves irrespective of their differences in religious, socio-economic, cultural, linguistic and gender-based positions. The college offers languagebased courses in English, and vernacular i.e. Bengali, Sanskrit and trying to introduce Arabic if sanctioned by the Higher Authority. The college has organised a good many workshops on gender sensitisation, especially among girl students by the initiative of the Women's Awareness Cell. They have also organised courses on Self-defence for the girls. The Eco Club of the college has taken significant steps of tree plantation and the importance of afforestation with the motto that if the environment lives then we also sustain it. The college has taken initiative for the Public Address System where the National Anthem will be played at every mid-noon to inculcate the sense of nationality and integrity of the state among the students. There is no discrimination in seating arrangements for students irrespective of their caste, creed, religion or socio-economic background. The college observes the important days either in physical mode or through online programmes like Republic Day, Independence Day, Women's Day, World Environment Day, Birthdays of Gandhiji, Rabindranath Tagore, Swami Vivekananda, Netaji Subhas Chandra Bose and the like. The college puts due importance on the activities of the NSS and NCC of the college, such activities which will inculcate discipline and social responsibility among students to prepare them as responsible citizens of the future. With due respect and regard to the religious beliefs of all the communities, the college gives scope to its students to celebrate Id, Muharram, Mahabir Jayanti, Birthday of Harichand Thakur, Christmas, Chhat Puja, Durga Puja and special days like Hul Diwas or Karam Puja for the students and staff who come from a tribal background. Practice 1:

Title: Educational Advent for Orphan Children Initiative of IQAC, Karimpur Pannadevi College

Objective:

The college is a social institution that has a social obligation also. Since there are a few orphanages in the locality and run mostly on grants which are not enough for the all-around development of the hapless inmates of these orphanages, the NSS Unit of our college thought of it as a scope to deliver some educational help to these children. The college has decided to extend its helping hand in lending the infrastructure of IT facilities and proper faculty to train the children in its usage with a little bit of entertainment though the film shows in a Saturday of every month and giving a lesson on drawing, recitation, and other cultural values.

Context:

The college to fulfil its social obligation has chosen the educational advent of the orphanages only because it felt that it is the area which not only needs a little bit of attention from the mainstream society but also empathy for those hapless children who are forsaken by their own from their very infancy. The college after discussions with them has found out that the little grants these orphanages get are less than enough to render them education and necessary items for their upbringing. The college faced the challenge of how to lend them this facility and sorted out that on one Saturday the selected faculty will carry the essential gadgets to the orphanages and train them as far as possible.

Practice:

There the children are given hands-on computer training, are introduced to the e-world and also organized drawing class. Since computer literacy is an essential demand nowadays, these orphan children are getting used to it and who can say that one day anyone of them will also be able to contribute to the fields of higher education? Since the motto of higher education is to bring out the best from the grassroots level, this advent of the college is surely proving fruitful for helping these orphans. But the college feels that it is less than enough but the college is constrained in lending ample IT facilities and the carrying of these gadgets and materials is also very troublesome and hazardous.

Evidence of Success: This project has imbibed a lot of enthusiasm among the students as they take pride in being a part of such a noble mission. The students after attending one or two programmes are now willing to give voluntary service for this project. Some students have committed to spend some time once or twice a week beyond their college hours to impart coaching to the children in arts, crafts, different performing arts etc. such endeavour from the students has attracted the notice of the media and their achievement and endeavour have been eulogized in a widely circulated vernacular newspaper.

Problems Encountered and Resource Required: The main hindrances in this project are time and money. Since the primary service of the college in an examination-oriented system is teaching and learning, helping the students to complete their curriculum within the stipulated period of time, the college is unable to manage enough time to devote to these children. If there had been more time, then better could have been done for these orphans.

Practice 2:

Title:

GRACE, The abbreviation stands for Guidance to Reach Academic and Competitive Examinations .

Objectives:

The goal of education is to achieve good jobs or avail an entry to good institutions after the UG course and such coaching facilities are available in urban areas. So, to avail of such coaching, it is a hardship for our students to manage the financial load in transport or manage a residence nearby and above all the course fees for such coaching. So, to make relief, as per the capacity of the college, the college has introduced free coaching to the interested students to face the challenges of the outer world when they pass out from the college.

Context:

The area of our college is a rural hinterland area where the lion's shares of inhabitants depend on farming and agriculture and are often economically weak. Most of the students who come from this background are generally first-generation learners. The nearest urban areas from Karimpur are Krishnagar and Baharampur which are almost 100 km distance away from either side. Now it is very hard for these students to travel such distances and the economic burden cannot at all be ignored. So, the college has resolved that if in some way it can provide such coaching facilities to them then it will be helpful. The idea behind such is twofold: first, those who give coaching in such commercial institutions are generally academicians from different HEIs and secondly, an HEI does have an obligation to society to cater for it with extra facilities.

Practice:

Interested teachers who want to impart free coaching under GRACE have registered their names and every detail is regularly uploaded to the college website. The college had sent Google forms to the students to register their names. The forms had been sent particularly to the students of the 4th and 6th Semesters because they are the ones who need them most. Since there is a compulsion and constraints to complete their UG curriculum under CBCS, the college has decided to start the programme from the month of March every year till the publication of results of the 6th Semester students.

Evidence of Success:

This has been started in the last academic year in our college. So, to get the evidence or to measure the success rate of the programme we need to wait another academic year. But the response we get from our students definitely ensures its some extra value in their future careers or further achievements.

Problems Encountered and resources required:

As we have already declared that GRACE is running only by our own faculty resources and the classes are arranged beyond the scheduled classes, sometimes it has been a major problem to arrange the classes on campus in extra time, because of the hard communication. Online classes are hampered by the poor network in remote villages.

7.3 Institutional Distinctiveness

7.3.1 Portray the performance of the Institution in one area distinctive to its priority and thrust within 1000 words

Response:

Promoting Higher education to Socio-Economically Backward castes and classes, minority students particularly to women and nurture a unique communal harmony:

From the onset of its establishment, Karimpur Pannadevi College had focused on the spread of Higher Education among the socio-economically underprivileged, backward youth of the locality irrespective of caste, creed, religion or gender. The foremost aim for the establishment of the college was to render Higher Education to the local youth where there was no college within the 100 km radius of Karimpur. At present, though some Government & Govt-aided college has been established within that area, still there is no college within the 40 km radius of Karimpur and as along with time, the population has increased the college is catering for the same need of the juvenile aspirants as it catered fifty years ago. Moreover, being situated in a hinterland on the edge of the Bangladesh border, the college is the only means of getting Higher Education (H.E) for those Indian citizens who reside in the no-man's land (e.g Meghnar *Chawar*) and has to exit and enter through the lock gates under the due surveillance of the B.S.F. From the very beginning the college has maintained its tradition of retaining indiscrimination among the boys and girl students and as the fairer sex is weakened in our societal setup, it has extended special facility for the girl students for their safety and security. And that is why for both the residents of no man's land and girl students, the college has framed its class routine in such a manner that there shall be no problem for them to attend the college and also ensured their safe and harassment-free return home.

Moreover our institution have done a examplenary work to promote women education who are basically the first generation learners, belongs to the economically below poverty line and socialy backward classes. Admission of girl's students of the minority family are also increased in last few years. HEI have secured their education by catering scholarships and financial assistance to them. State government authority have already provide us the certifiacte in honour of this work in consucative years. Recently college has decided to provide financial assistance to the passed out students who have secured their PG studies in government Universities.

Apart form these the admission data prove that the college have been playing a crucial role to promote higher education among the students belongs to SC and other backward classes. Almost all the reserve category seats for SC and OBC (A and B) are fullfilled in respect of their intake capacity.

Since a larger share of the local population is comprised of people from the backward caste, classes and community, keeping in tune with the motto of communal harmony, the tune with the motto of communal harmony, college renders its service to its pupils irrespective of their caste, creed or religion. The college offers various kinds of stipends and scholarships for students of backward classes and minority communities. From the very beginning the college performs the festival of *Saraswati Puja* (The worship of the Goddess of knowledge) and though it is a Hindu festival is organised by students of all communities under the supervision of teaching and non-teaching staff which is an evident example of upholding the spirit of communal harmony. This spirit is also maintained through the fact that the college announces holidays for the festivals of all the community. So, the college is successful in carrying out its mission with the same vision with which it was established fifty years ago.
